The Pas OCN Chamber of Commerce wishes to invite you to participate in our 2024 ANNUAL TRADE SHOW & SALE.

Trade Shows represent a powerful opportunity to enhance brand and product visibility, promote new and existing products, generate leads and drive sales.

In addition, show participation enables you to learn about industry trends, gain competitor insights, make key industry contacts, and further solidify relationships with current customers.

The 2024 show is open to any business.

TRADE SHOW & SALE applications will be processed as follows:

- 1. "Early Bird" REDUCED BOOTH PRICE If payment is received by **April 15th**, 2024, you are entitled to a \$100.00 discount per booth (\$100.00 + \$5.00 GST), excluding tables.
- 2. PREVIOUS YEAR EXHIBITOR Same spot must be booked by: **April 15, 2024**, to ensure your preferred location.
- 3. PREVIOUS YEAR EXHIBITOR & NEW EXHIBITOR Must book by: April 30, 2024 (or by April 15<sup>th</sup> to get discount).
- 4. Tables 8 foot tables are available for smaller business, home businesses and crafts people and must be booked by **April 30, 2023**. Fee is **\$105.00 plus GST.**
- 5. IF SOLD OUT Refund will be given if no booths are available.
- 6. ALL DECISIONS by current Chamber Executive are FINAL

Submit your documentation and remittance as soon as possible to increase your chance of securing your desired booth location. Please indicate your first, second and third choice locations on your application, as well as any special services you may require (e.g., access to electrical outlets, etc.).

PLEASE NOTE: WE DO NOT SUPPLY EXTENSION CORDS, ONLY ACCESS TO ELECTRICITY.

Your fee includes one 90 second live remote during the show or option of three 30 second commercials with additional advertising available at drastically reduced rates

In order to further improve public attendance and increase public enthusiasm, we strongly encourage you to offer a varied special (or specials), each day that the show is open to the public. Ensure these specials are advertised through the vehicles offered.

Please ensure that your booth is staffed throughout the show. Booths that have been or appear to have been "abandoned" for excessive lengths of time diminish the quality of the show. If the booth attendee is working alone and requires a break, we suggest asking a "neighbour" to watch the booth, and/or a sign "BACK IN .... MINUTES" is displayed. Also, you can speak to the organizer about the possibility of arranging for someone to watch your booth while the staff member is gone.

We have always endeavored to have a wide variety of products at our show. *Exhibitors may* be limited to specific products to avoid excessive product duplication at the show. This will be determined on a first come first served basis. When submitting your application, please provide a sufficiently detailed description of your product line.

At this time, we are requesting an item for our Silent Auction. Silent Auction items will be on display in the main lobby, attached will be a donation card with your company name and booth number. This will aid the public in a preview of your product, and you will gain exposure as a vendor.


