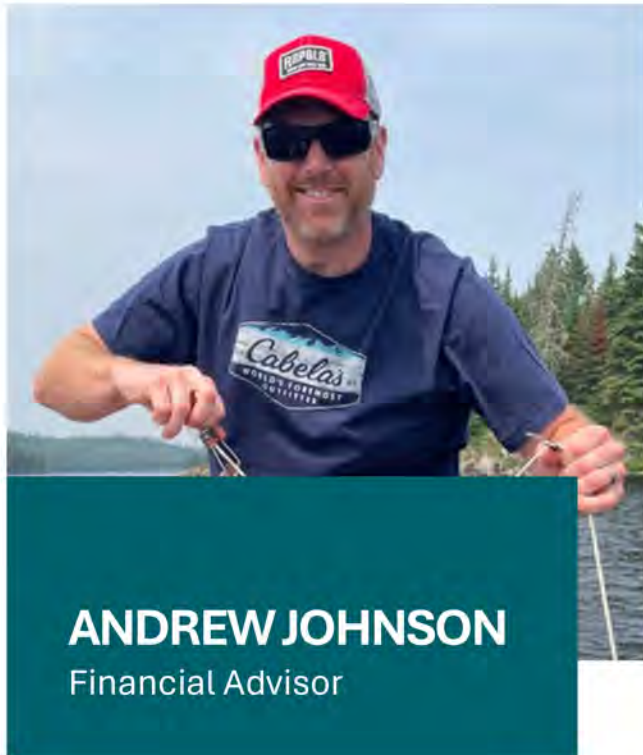

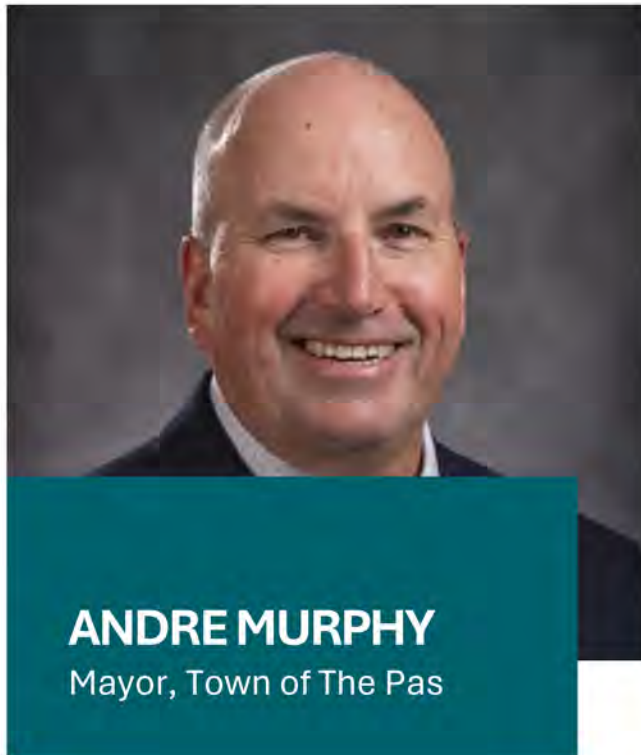

# MESSAGE FROM THE PRESIDENT

It's my pleasure to present this year's President's Report and to reflect on some of the highlights and activities that have shaped another successful year for our Chamber.

We kicked off our event season with our Annual Trade Show, held at the Roy H Johnson arena in early May. This year's trade show was one of our most successful yet — we saw an increase in both vendors and foot traffic, with many exhibitors commenting on the positive energy and strong community turnout, in spite of the evacuations and looming fires. It's always a great way to launch the summer season, and it continues to be one of our signature events that brings businesses and residents together in a meaningful way.

Later in May- while our Norman Blizzard were on their championship run, Jonathan from the CDC and I had the opportunity to attend the Manitoba Chamber of Commerce Annual General Meeting held in the Winkler-Morden area. It was a fantastic event that brought together Chamber representatives, business owners, and industry leaders from across the province and country. We had the opportunity to connect with leaders from a variety of sectors and industries, sharing insights and ideas that strengthen our collective voice within Manitoba's business community. The event also featured several keynote speakers, including the Minister of Finance for the Province of Manitoba, who provided valuable perspectives on the current state of the economy. Much of the discussion centered around navigating economic uncertainty in the current tariff-driven trade environment, and how local Chambers can support their members in adapting to these broader challenges.

I moderated our federal election debate, co-hosted with UCN and Monte Koshel and we saw great community turn out and involvement. Following that and with the election of a new Member of Parliament for our region, we were able to begin building a strong working relationship and focusing on shared goals that directly benefit our communities.

One of our main areas of collaboration has been advocating for and pursuing infrastructure funding and new investment in the tri-community area — progress that is both much needed and long overdue. These discussions have laid a strong foundation for continued partnership and growth in the years ahead.

2025 has seen an increased partnership with the The Pas Community Development Corporation (CDC) to offer funding opportunities for local business owners in the tri-community area, helping to offset the costs of investing in and improving their storefronts. This initiative not only enhanced the look and vitality of our business districts but also encouraged local reinvestment and pride in our communities.

Throughout the year, we also saw a steady increase in Chamber membership and hosted several Lunch and Learn events, which received excellent participation and support from our local business community. These sessions provided valuable networking opportunities and practical insights for our members and community, reinforcing the Chamber's role as a hub for connection, education, and advocacy.

It was a great year for new business openings in town and the chamber was blessed to be able to attend the grand openings of Thrifter Sisters, Aurora Optical and NCN Thompson Bus Lines. Amazing to see business growth in the community!

As we close out the year, I'd like to extend my sincere thanks to our Board of Directors and all Chamber members for their continued dedication and support. We truly have an incredible business community here — one that's innovative, collaborative, and resilient. Together, we've achieved a great deal this year, and I'm confident we'll continue building on that momentum in the year ahead.

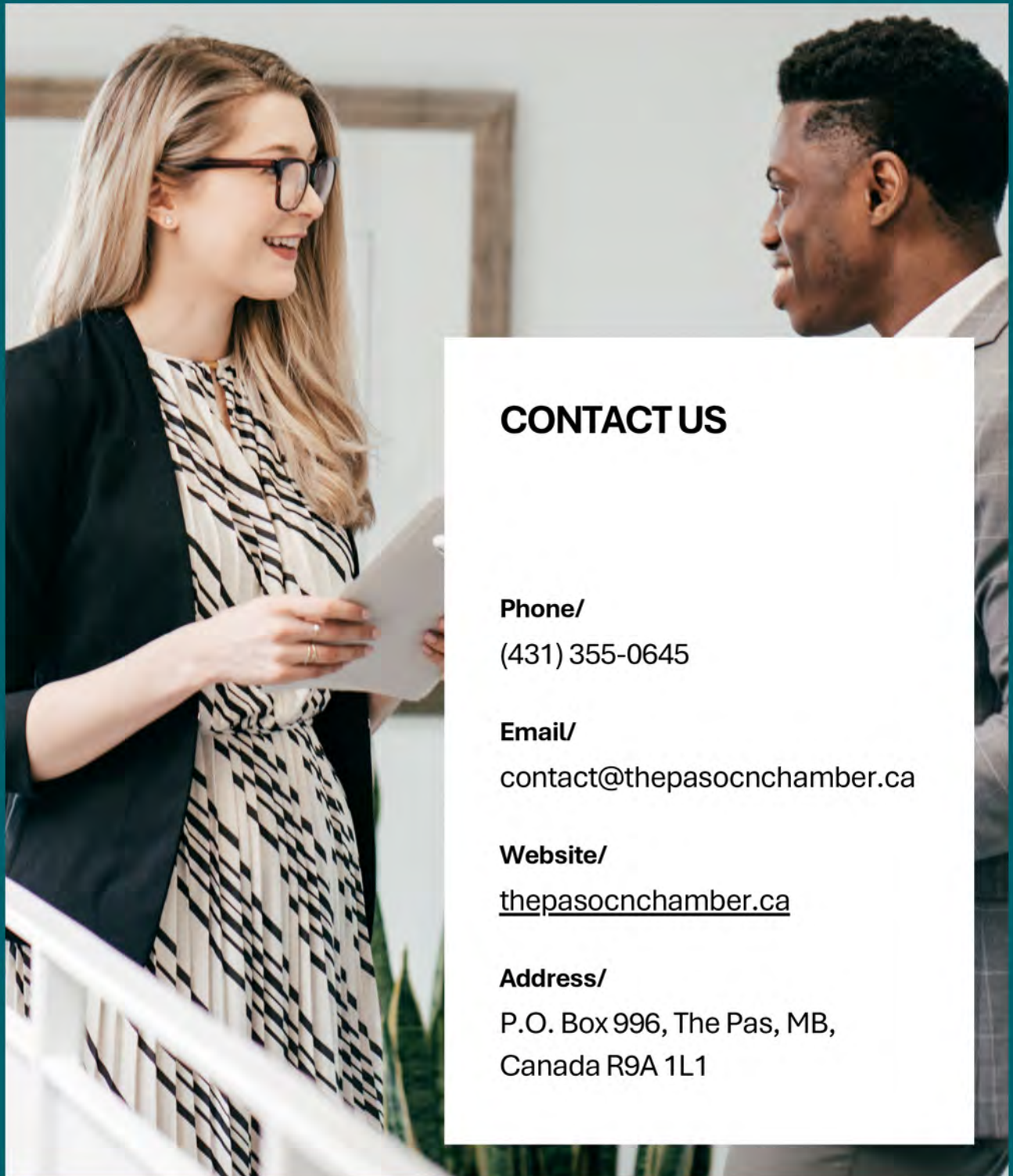
